MUSLIM YOUTH TALENT RECOGNITION BY WQT- THE VISUAL ARTS CONTESTCONTEST 2021, hereafter referred as "The Contest" is sponsored by WORLDWIDE QURAN THINKERS, hereafter referred as "WQT". THE CONTEST begins at 11:50 pm ET, March 15th, 2021, and ends at 11:50 pm ET April 30th, 2021, hereafter referred as "The Contest Period", and April 30th, 2021 at 11:50pm ET hereafter referred as "The Contest Deadline".

### Eligibility of Participants

The Contest is ONLY for Muslims who are residing in Canada as Citizens, Permanent Residents, Refugee or International Students who are at age under 18 years or younger at the time of the deadline of the contest.

Any Relatives, employees, agents, and representatives of WQT and those on the Judging Panel, as well as members of their immediate family (brothers, sisters, children, father, mother), their legal or common-law spouse are not eligible to participate in The Contest. The contest is for children/teens under 18 years old. Entries must be made by either the parent or legal guardian of the minor on behalf of the Minor.

### Broad Parameters of The Contest

**ONLY for Muslim Children, Teen and Youth Residing in Canada as Citizen, permanent residents, refugee or international students:** This contest has been designed for Muslim Children, Teen and Youth in order to encourage their better inclusion within the Canadian Society and to identify talented young Muslims by making them role models and youth mentors with the basic aim for Muslims to better participate and contribute to the wellbeing of the Canadian society and economy.

**Have to Adhere to Quranic Parameters of Decency, Respect, Privacy, Morality & Ethics:** The Submission must not contain unsuitable materials such as images, illustrations, or words that may be abusive, obscene, offensive, and/or involving profanity. WQT reserved the right to disqualify entries containing such matter. Entries must be suitable to be published and/or used for illustrative purposes for audiences of all ages, but in particular for a child audience. The submitted entries must adhere to the Quranic parameters and commandments of Allah as given in Quran related to the following:

- Decency: Must not contain any indecent images, illustrations, language, phrase or expression of any sort whatsoever.
- Respect: Must respect and treat each and every individual with utmost level of respect, honor and dignity.
- Privacy: Must not breach any private and confidential boundaries of any person, any painter, any artist, any website, any book, etc.
- Morality and Ethics: Must adhere to the general moral and ethical principals.

**Other Religions and/or Muslims' Beliefs:** Must not make fun of, ridicule, go against any other religion, or any religious beliefs and/or any sects within Muslims.

### How to Submit Entries

NO PURCHASE NECESSARY. Internet access required. There is no limit to submission per person.

### Conditions & Parameters for Each Submission for The Contest

**File format:** Please submit your scanned artwork in high resolution in any of the image files such as JPEG or PNG format. You can use words and quotes if you like in your illustrations.

### General:

- Visual Arts must be original and must be created by the Participant on his/her own. Any assistance from anyone else, or any copy from any

painter, Blog, book, website, any other media etc. is not allowed and would result in disqualification.

- One participant can submit multiple entries but each entry has to be created by a single participant. Only single Participant Visual Arts qualifies. Any entry which is co-created/worked upon by two or more persons will be disqualified.
- The words/quotes on the artwork will be accepted in English only.
- The Submission must not contain unsuitable materials such as abusive, obscene, offensive, and profanity language, illustrations, graphics or images.
- Entries must be suitable to be published or used for illustrations for audiences of all ages, but in particular for a child audience.
- There is no entry fee and no purchase is necessary.
- Entry must be submitted along with an authentic document confirming date of birth of the Participant.
- Only entries submitted via email will be accepted.
- Any portion of the Submission entered which is protected by copyright, any other intellectual property right or the right of a third party, will be disqualified.

### Judging Criteria

During the Contest Period, all Submissions will be reviewed by a panel, referred as the "Judging Panel" which will include people from a variety of different backgrounds and occupations. WQT and its representatives have the sole authority to select the Judging Panel as deemed fit. The Submission selected to be the winner, 2<sup>nd</sup> prize winner and 3<sup>rd</sup> prize winner from each Age Group will be as per the sole discretion of the Judging Panel, WQT and its representatives.

### Winning Prize

After 15 days of the Contest deadline, WQT will announce the winner from each Age Group. Awarding of Prize will be done during a prize distribution ceremony on line, the date of which will be announced later.

The Prize winners will be contacted by WQT through the email address as provided on the entry form. Before being declared the winner of the Prize, the Participant and their parent or guardian whose Submission has been declared as the winner must first:

Complete and return to WQT (or its authorized agent) by the deadline specified in the documents a written declaration and release (the "Declaration and Release"), declaring that the Participant is eligible to win the prize in accordance with these Contest Rules and releasing WQT, and all of its respective directors, officers, owners, partners, shareholders, employees, agents, representatives, successors and assigns, other affiliated companies and Judging Panel from any liability in connection with this Contest, or the use, misuse or possession of any prize-related thereto.
